#### INDEPENDENT PRACTITIONER'S REVIEW ENGAGEMENT REPORT

To the Board of Directors
British Columbia Archery Association

We have reviewed the accompanying financial statements of British Columbia Archery Association that comprise the statement of financial position as at March 31, 2021, and the statements of operations and changes in net assets and cash flows for the year then ended, as well as a summary of significant accounting policies and other explanatory information.

#### Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

#### Practitioner's Responsibility

Our responsibility is to express a conclusion on the accompanying financial statements based on our review. We conducted our review in accordance with Canadian generally accepted standards for review engagements, which require us to comply with relevant ethical requirements.

A review of financial statements in accordance with Canadian generally accepted standards for review engagements is a limited assurance engagement. The practitioner performs procedures, primarily consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates the evidence obtained.

The procedures performed in a review are substantially less in extent than, and vary in nature from, those performed in an audit conducted in accordance with Canadian generally accepted auditing standards. Accordingly, we do not express an audit opinion on these financial statements.

#### Conclusion

Based on our review, nothing has come to our attention causing us to believe that the financial statements do not present fairly, in all material respects, the financial position of British Columbia Archery Association as at March 31, 2021 and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

## BRITISH COLUMBIA ARCHERY ASSOCIATION NOTES TO FINANCIAL STATEMENTS MARCH 31, 2021

(Unaudited)

#### PURPOSE OF THE ORGANIZATION

The British Columbia Archery Association was formed to perpetuate, foster, and manage the practice of archery and without limiting the generality of the foregoing; to adopt, interpret, and enforce rules for the practice of archery in all its forms; to hold annual tournaments for the purpose of determining the Champions for the British Columbia Archery Association; and to act in general as the supreme governing body in all matters that pertain to archery in the Province of British Columbia, Canada. The Association is registered under the Society Act of British Columbia and is not subject to income tax. The Association is not a registered charity under the Income Tax Act and therefore cannot issue charitable donation receipts.

#### Note 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### a) Basis of Presentation

The Association prepares its financial statements in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO).

#### b) Use of estimates

When preparing financial statements according to ASNPO, estimates and assumptions are made relating to reported amounts of revenue and expenditure, assets and liabilities and disclosure of contingent assets and liabilities. Assumptions are based on a number of factors, including historical experience, current events, actions that the Association may undertake in the future, and other assumptions that are believed to be reasonable under the circumstances. Actual results could differ from those estimates under different conditions and assumptions. Estimates are used when accounting for certain items such as useful lifes of capital assets and impairment of long-lived assets.

#### c) Capital assets

The capital assets are recorded at cost. Amortization is provided annually at rates and methods over the estimated useful lives as follows, prorated for the number of months of ownership. The estimates of the useful lives of the assets are reviewed every year and adjusted on a prospective basis, if needed.

Impairment of capital assets is reviewed whenever events or changes in the circumstances indicate that the carrying value may not be recoverable. An impairment loss is recognized for the excess of the carrying value over the fair value of the asset, during the year the impairment occurred.

#### Note 2 FINANCIAL INSTRUMENTS

The Association's financial instruments consist of cash, accounts receivable, and accounts payable. Unless otherwise noted, it is the opinion of management that the Association is not exposed to significant interest, currency, or credit risks arising from these financial instruments. The fair value of the instruments approximates their carrying values, unless otherwise noted.

#### Note 5 RELATED PARTY TRANSACTIONS

The Association paid the directors \$1,650 for services rendered (\$16,292 in 2020, \$18,191 in 2019). These amounts are included in honorariums and awards.

#### Note 6 INTERNALLY RESTRICTED RESERVES

Funds have been restricted internally by the Board of Directors to cover the salary of the Executive Director for one year should the position be dissolved. This reserve would allow for the continuation of the duties of this position until they are reallocated to volunteers. The total in this reserve is \$55,000.

Funds have been restricted internally by the Board of Directors for future tournament equipment expenditures. The total in this reserve is \$10,000.

#### **Report of the Executive Director**

Word of the year for 2021: DYNAMIC

- (ADJ) a process or system characterised by constant change, activity or progress
- (NOUN) a force that stimulates change or progress within a system or project

2020 and 2021 have been fueled by constant change, sadly, not in an ideal way.

Our provincial championships were once again cancelled, as were many local, national and international events that we may have hoped to attend, all in the name of the COVID-19 pandemic. But it hasn't beaten us. We are still here. And although we have missed holding many archery events and programs, we have hopes and plans for the future—whatever that may bring.

In trying to navigate the COVID restrictions, I have attended more viaSport & PSO meetings than I would like to count, often more than one a week. These gatherings of amateur sport organizations in BC provided a wonderful dynamic where ideas and solutions were brainstormed on implementing government restrictions, offering (limited) sport programming, and effectively communicating pandemic-related guidelines to our clubs, members and participants. Although the current recommendations state that COVID-related safety plans are to pivot to Communicable Disease Prevention Plans, it would be wise to keep your current plans handy, as we still don't know what may happen with regard to restrictions in the Fall and Winter as archery returns to indoor venues.

Interpodia was introduced as a new third-party membership and event registration system, spearheaded by Archery Canada. After a few bumps, I believe the system is working well. I would recommend that all our affiliated clubs consider signing up with this system as it could alleviate the pressure on club volunteers and assist with tournament registrations.

Planning for the 2022 Greater Vernon BC Winter Games officially kicked off at the end of 2020. The Provincial Advisors for each sport and the Games staff have proceeded, knowing that these games will be "different". Without a crystal ball to tell us what the world might look like in February 2022, the planning process can be characterized fluid, dynamic. This time, there will be no opening or closing ceremonies, no social events with other sports, and very little integration with non-archery participants. We are planning with caution and care, to ensure the safety of everyone involved, but still to provide the best event possible. BC Games continues to express their pleasure in working with BC Archery. As the Provincial Advisor, I'm looking forward to "the big sleepover" in February, and I hope that the participants are still able to have that event-of-a-lifetime experience. I would like to thank all coaches and officials for the countless, often thankless, hours they spend helping our young athletes to achieve their goals.

As you may know, BC Archery receives approximately 40% of its "normal" revenue through a government contribution agreement. (In the 2020-2021 fiscal year, including a grant received from the Federal government, this accounted for almost 62% of revenues). viaSport is the intermediary organization that manages sport funding from the provincial government to the provincial sport organizations (PSOs). And in order to maintain that funding, the government sets certain "priorities" as to how it gets spent. The greatest of these priorities, for the near-future, is around Safe Sport—adhering to the new BCUCC (BC Universal Code of Conduct) and delivering a quality sport experience. The provincial government created a <u>Pathways to Sport</u> strategic framework which is to guide the delivery and growth of sport participation in BC. It is expected that all funded organizations implement the

strategies laid out in this initiative. BC Archery will be working to create or revise policies and programming offered in order to comply with the recommendation in the framework.

I would like to end, as always, by giving thanks to all the volunteers out there. No matter the extent of your help—whether you help at your club by teaching kids to keep score, running a concession at your 3D, sitting on the Board of your local club, or sitting on a committee with BC Archery or Archery Canada—you are valuable, and you probably don't hear the words enough:  $\mathcal{THANK}$   $\mathcal{YOU}$ 

And if you feel that you have some experience that may benefit BC Archery and our members, you are a dynamic individual, and would like to join us as we implement advancements in our governance and programming, we welcome your assistance. We are in this together, and together we can be a stronger, better Society.

#### **Report of the VP-Administration**

Over the year, I have been working on the Strategic Plan keeping portions related to my portfolio updated, doing research on Safe Sport in preparation of messaging our BC Archery affiliated clubs as to what is available to them and the benefits of being a BC Archery member/affiliate. I am presently working on updating the BC Archery Hosting Manual to bring it in line with the Archery Canada Hosting Manual.

#### Report of the VP-3D and Bowhunting

With some Covid 19 restrictions being lifted, there were many communities/clubs hosting outdoor fun 3D shoots across the province attracting thousands of participants this summer. Unfortunately, our yearly BC 3D Championships were cancelled due to the Covid 19 pandemic.

The 2022 BC 3D Championships are to be hosted by Cranbrook. At these BC Championships, the eight-person BC Team and four alternates will be chosen using a handicapping system, to compete at the Prince Edward Island Canadian Championships. Cranbrook is also slated to host the Canadian Championships in 2023.

In 2019, 12 of 12 BC Team members made the podium in Saskatchewan. Of the 35 archers from BC, 21 (60%) made it to the podium. That is the best result we have ever had for the team and possibly for BC archers as a whole! We expect a similar percentage result for 2022 in PEI.

The choosing of the BC Team continues to evolve. With the majority of the team reaching the podium at each of the last five Canadian Championships, our choosing system is working well. However, I am still working to make it as fair as possible. Through education of the host clubs, instituting team alternates and the fact that the alternates have an equal chance to share in 50% of available team funding through their performance, the inevitable course inequities are felt less harshly. I continue to monitor and strive to improve the process.

No International Bowhunter Education Program (IBEP) courses were held this past year.

#### **Targeted Athlete Program Coordinator**

In the absence of competition for more than a year, with the exception of 2020BC Winter Games which squeaked in just before the COVID shutdown, we extended the inclusion time of benchmark required scores from 12months to 24months at the suggestion of Pacific Sport. The 2021 cycle included recurve and compound and we are currently working with Pacific Sport to include the introduction of barebow benchmarks, following the 2019 inclusion of Barebow at the target archery world level.

The list of athletes and their coaches is posted on the BC Archery website under the 2021 cycle, and includes our 4 National Sport Organization (NSO) carded athletes (GO BC!). This year we were proud to target 2 athletes meeting the Canadian Dev Level, 2 athletes at the Provincial Development Level 1 and 4 athletes meeting the Provincial Development Level 2 criteria.

It is important for athletes to take advantage of the programs available to them and for coaches to be aware of those opportunities. As part of the TAP, Pacific Sport/CSI offers Medical resources, grants and bursaries, Sport Performance Speaker Series, and other athlete resources to develop our athletes mentally, nutritionally and provide access to resources to assist with promoting and fundraising. Additionally, the TAP Program offers a community partnership between local restaurants/grocery stores that can provide affordable options for healthy eating (Discounted products/services). Pacific Sport also offers the IGNITE Athlete Development program for a high-performance training environment. Sports are assessed for their eligibility to receive viaSport Excellence funding based on uptake of programs like these and the conversion rates of athletes moving through the developmental levels.

#### **Report of the Judge Chair**

#### Officiating Committee

- Met twice so far in 2021.
- The Judge certification process is now described in detail in a "Judge Certification Process Flow chart"
- The Judge and Judge Candidate Status is update based on interviews, review of documents (including emails) and knowledge of committee and other members.
- Completed and approved BC Archery Provincial Judge Reaccreditation guidelines.
- Completed and approved BC Archery Judges course Modules content.
- Reviewed the changes to rules for 2019 and 2020 by AC and WA. Will be issued in the "Covid-19

   resumption of regular activities"
- Completed and approved the first Judge specific Newsletter (Red Shirt Journal) issued the in July. The Intent is to issue 2 to 4 times per year.

#### AC Range Safety Officer (RSO) Manual

AC will be issuing a revised RSO manual this year. I was asked to review and made recommendations. I found the document to be well laid out and information pertinent. It is the

intention of AC to require a potential Provincial Judge Candidate to have RSO designation before being accepted to attend workshops etc.

#### AC National Standardization of the Provincial Judge Certification Program

I represented BC Archery in Archery Canada conference call of February 3, 2021. Each Province and the Yukon were represented. There was a positive consensus to nationalizing the provincial judging program. AC has added Appendix 4 to Rule Book One 2021 version titled "Organisation and Procedure for the Judges Committee" which in turn lays out requirement for Provincial Judge training and accreditation.

On June 23, 2021 the Board approved our commitment to the AC National Standardization of the Provincial Judge Certification Program.

I have proposed to AC a process, similar to that for NCCP coach training, for Judges and Judge Learning facilitators using NCCP standards where appropriate. This would include but not limited to; 1) workshop training (in person or virtual), 2) use a workbook/ reference material process similar to coaching, 3) workshop evaluation by LF using workbook, presentations and case studies and on-line exam, 4) practical training and 5) evaluation and certification.

The first edition of the Red Shirt Journal was sent to individuals who were identified as Judges in the recent past, for a total of 47. The general terms for Provincial Judge Certification: Maintenance, Renewal & Reaccreditation Process and BC Archery's commitment to the AC National Standardization of the Provincial Judge Certification Program was reviewed. At the end of the newsletter the question was asked, "Do you wish to continue to be recognized as a certified Provincial Judge?". The individual was directed to a virtual form to answer the question. The purpose was to ensure we are directing out efforts to the appropriate individuals and their accreditation.

#### Objectives for 2022

- 1. Create reference materials, workbooks and presentation materials for workshops aligning with AC requirements.
- 2. Develop, implement and track a process for Judges to attend Championships and other events as part of their renewal requirements.
- 3. Complete the certification of current Judge Candidates.

It is my intention to carry on as the Judge Chairperson for 2021/2022. I will resign from the Judge Chairperson at the 2022 AGM.

#### SOCIETIES ACT (BRITISH COLUMBIA)

#### Persons qualified to be directors

- 44 (1) A person is qualified to be a director of a society only if the person is an individual who is at least 18 years of age.
- (2) Despite subsection (1), an individual who is 16 or 17 years of age is qualified to be a director of a society if provided for in the regulations.
- (3) Despite subsections (1) and (2), an individual is not qualified to be a director of a society if the individual is
  - (a) found by any court, in Canada or elsewhere, to be incapable of managing the individual's own affairs,
  - (b) an undischarged bankrupt, or
  - (c) convicted in or out of British Columbia of an offence in connection with the promotion, formation or management of a corporation or unincorporated entity, or of an offence involving fraud, unless
    - (i) the court orders otherwise,
    - (ii) 5 years have elapsed since the last to occur of
      - (A) the expiration of the period set for suspension of the passing of sentence without a sentence having been passed,
      - (B) the imposition of a fine,
      - (C) the conclusion of the term of any imprisonment, and
      - (D) the conclusion of the term of any probation imposed, or
    - (iii) a pardon was granted or issued, or a record suspension was ordered, under the *Criminal Records Act* (Canada) and the pardon or record suspension, as the case may be, has not been revoked or ceased to have effect.
